STAGING & EQUIPMENT RENTAL AGREEMENT

This Staging & Equipment Rental Agreement (together, with all Appendices and Terms and Conditions, collectively the "Agreement") is entered into as of the Effective Date identified below, by and between Client (as defined below) and GoryGirl, LLC, a California limited liability company ("GoryGirl"), each of whom hereby agrees as follows:

Fees. In exchange for the Fees outlined in Appendix "A," and subject to the other terms and conditions in this Agreement, GoryGirl will lease Equipment (as defined below) to Client and, where applicable and memorialized in Appendix "A," use reasonable commercial efforts to design, develop, and stage the location ("Services," as defined below) identified in Appendix A.

Equipment. The term "Equipment" shall mean any and all property or equipment leased by Client from GoryGirl, including any Equipment utilized by GoryGirl.

Services. The term "Services" shall mean any and all design and staging services provided by GoryGirl, if any, outlined in Appendix "A."

AS-IS. Client acknowledges that all Equipment is provided on an "As-Is" basis. GoryGirl is not a dealer, does not make any representation, warranty or covenant with respect to the condition of the Equipment in any respect or its fitness for any particular use, or any other representation, warranty or covenant, express or implied.

Replacement Value. Client acknowledges that the Equipment is unique. Client shall, at its own cost and expense; protect, keep, and maintain Equipment in a good state of operating condition, normal wear and tear accepted. If any Equipment leased or otherwise utilized in Services is, in GoryGirl's reasonable discretion, lost, damaged or destroyed, Client shall promptly pay GoryGirl the value of any such lost or destroyed Equipment as identified on Appendix B, all of which are always charged in addition to Fees in Appendix A or any other costs.

Indemnity. Client hereby agrees to indemnify and hold harmless GoryGirl and its officers, members, managers, employees, vendors, agents, and contractors (collectively, "Indemnified Persons"), from and against all threatened or asserted claims, liabilities, losses, damages, and expenses as incurred (including reasonable legal fees and disbursements of counsel and the costs of GoryGirl professional time) (collectively "Losses"), relating to or arising out of Client's possession, use, or leasing of the

Equipment. Client shall not, however, be liable under the foregoing indemnity provision to the extent that any such Losses are determined by a court of competent jurisdiction to have resulted primarily from the gross negligence, willful misconduct, or bad faith of any Indemnified Person.

Damage Limitation. NEITHER GORYGIRL, NOR ITS OFFICERS, MEMBERS, MANAGERS, EMPLOYEES, VENDORS, AGENTS, OR CONTRACTORS SHALL HAVE ANY LIABILITY FOR INCIDENTAL, CONSEQUENTIAL, INDIRECT, SPECIAL OR PUNITIVE DAMAGES OR LIABILITIES OF ANY KIND OR FOR LOSS OF REVENUE, LOSS OF BUSINESS, OR OTHER FINANCIAL LOSS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, REGARDLESS OF THE FORM OF THE ACTION, WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT PRODUCT LIABILITY OR OTHERWISE, EVEN IF ANY REPRESENTATIVE OF A PARTY HERETO HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS DEEMED TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

Terms and Conditions. The Terms and Conditions are attached hereto, incorporated herein and made a part hereof.

TERMS & CONDITIONS

Terms of Agreement and Modifications. The Agreement contains all of the terms upon which the Equipment is leased and supersedes and controls any other proposals, written or unwritten, given with respect thereto unless the terms hereof are expressly modified by a later agreement signed by the parties.

No Alterations/Modifications. The Equipment shall not be altered or modified by the Client without the express written consent of GoryGirl.

Insurance Requirements. Client shall secure and maintain (i) All Risk Physical Damage insurance including coverage for collision and upset and comprehensive losses to the Equipment rented from GoryGirl hereunder, and (ii) Comprehensive General Liability insurance in an amount of not less than \$1,000,000. Combined Single limit for personal injury, bodily injury, and property damage. The Comprehensive General Liability form shall include the coverage parts for broad form contractual liability. This insurance shall remain in full force and effect until Client has returned all Equipment to GoryGirl.

Return and Termination. On any termination of this Agreement, all Equipment shall be returned to GoryGirl in the same condition and repair as when received by Client, normal wear and tear excepted. All costs of transportation from and to GoryGirl's designated drop-off location shall be borne exclusively by Client.

Deposits. All deposits received by GoryGirl shall be held and deposited as security for the performance of the Client's agreement hereunder and, at the option of GoryGirl, may be applied to the payment of rent as it comes due, and/or to repair any damage incurred to said items while under the care of Client and/or to cure any default of Client, without prejudice to or suspension of any other right or remedy of GoryGirl. The security deposit also may be held and used by GoryGirl until all of the Client's obligations are fully performed and the items returned to GoryGirl. The amount of any deposit in no way defines or limits the Client's liability for costs or obligations to GoryGirl incurred by Client.

No Transfer. This Agreement in no way implies transfer of ownership of title of any Equipment.

No Assignment. Client shall not assign this contract or any of its rights or obligations hereunder, nor shall the same be assignable by operation of law, without the prior written consent of GoryGirl. Client shall not loan, rent or sublease the Equipment nor allow any third party to use the Equipment.

Certificate of Insurance. Client shall provide GoryGirl with a Certificate of Insurance, signed by an authorized representative

of the Client's insurance company, evidencing that Client is in compliance with the insurance provisions of this Agreement, including naming GoryGirl as Additional Insured and Loss Payee as GoryGirl's interest may appear in reference to any and all Equipment provided by GoryGirl under the terms and conditions of this Agreement. Any insurance certificate provided in accordance with this Agreement shall stipulate that GoryGirl shall receive 30 days written notice of cancellation from the insurance company providing the required coverage prior to any cancellation or reduction in the limits of liability; each such certificate issued to GoryGirl shall stipulate that the coverage indicated on the insurance certificate shall be primary coverage and not contributing with any other insurance maintained by GoryGirl. Client covenants that Client's insurance coverage shall commence at the time of any of the GoryGirl's Equipment leaves GoryGirl's premises and shall remain in full force and effect until the Equipment is returned to GoryGirl. Equipment coverage shall be provided on replacement cost basis. If actual cash value basis, Client shall pay difference between actual cash value and replacement cost.

Controlling Law. This Agreement shall be governed in all respects by the laws of the United States and the State of California as such laws are applied to agreements between California residents entered into and to be performed entirely within California.

Arbitration. Any dispute which arises under this Agreement shall, unless otherwise mutually agreed in writing, be submitted to final and binding arbitration. The parties agree that such arbitration shall be the sole and exclusive process for adjudication of disputes relating to the Agreement. A single arbitrator shall be selected and the arbitration shall be administered by JAMS and conducted in accordance with JAMS Comprehensive Rules & Procedures in effect at the time the claim is made.

Notwithstanding, any rules or provisions to the contrary, the arbitrator shall have full authority to award any relief in law or equity, which the arbitrator deems appropriate to remedy any breach of this Agreement. All arbitration proceedings shall be conducted in Los Angeles, California.

Independent Contractor.

Client and GoryGirl are and at all times shall be and remain independent contractors as to each other, and at no time shall either be deemed to be the agent of the other, and no joint venture, partnership, agency or other relationship shall be created or implied hereby or herefrom.

Publicity. Neither party shall, without the other party's prior written approval make any public announcement or disclosure as to the existence of or matters set forth in this Agreement.
